

This paper estimates Japan's output gap using the recently developed l1 trend filter, which is an alternative to the popular Hodrick-Prescott (HP) filter. This new filter gives a piecewise linear trend line that means it possibly provides better output gap estimates than the HP filter does for an economy like Japan that has experienced some structural breaks.
