## Capital Flows and Investor Protection

## Abstract

This paper studies how politics determine the degree of financial development in international financial markets. The government determines the amount of public expenditure and the quality of investor protection, which affects borrowing constraints. Capital inflows reduce domestic investors' stake and mitigate their concerns for the government policies. We show that when there are large capital inflows, the rich vote for large public expenditure and better investor protection.
